**Presentations:** Carson Kuenzi, Pacific Sanitation regarding fee increases. Serving approximately 400 residential customers with most using the recycle cars. ### **Unfinished Business:**

- **Park Project** The swing set was installed yesterday. The park will remain closed until the end of the week to allow for the concrete to cure. The Freres pavilion sign has been installed.
- **FEMA Floodplain Changes** We are working with the attorney to assist us with these changes. FEMA is making significant changes to the floodplain regulations, which

requires us to make changes to our land use code. The council has the choice of banning all development within the 100-year floodplain, allow on a permit-by-permit basis, or update the current code with a new Model Ordinance provided by FEMA. The permit-by-permit choice would require a habitat assessment that would be significant cost to the property owner which would likely discourage any changes or development. *Councilor Wagner motioned to initiate an amendment to the Lyons Municipal Coe and direct staff to move forward with the adoption of a tailored version of the updated 2024 FEMA Model Ordinance – Councilor Ritchie second – all in favor – none opposed – motion passed.* 

## **New Business:**

• **Pole Banners** – Applications have been submitted to ODOT, Linn County Road Department, and to Pacific Power to install 25 holiday banners along 5th Street and Main Street. The banners have not been purchased yet, waiting for approvals. The approximate cost for the banners and brackets is \$3,875.00. Pacific Power will install at no charge, as a community service project. The intention is that the brackets will be mounted permanently so that seasonal banners may be switched-out through the year.

Library Director Report: The library report is provided.

**City Manager Report**: CM Valentine reports there was some graffiti found on a couple picnic tables which was removed. The amount of trash has reduced significantly. Linn County Parks has been awarded a grant to improve John Neal Park including improvements to the trails and bridges. Linn County Road Department delivered the street signs. It will likely be spring/summer before we can get them installed. There was one cremains burial. The ramp light at the library is still not working but we have been notified that it will be fixed this week. There were two mechanical permits issued. Working with North Santiam School District on an IT Service IGA. Reminder of upcoming dinner and CM vacation in December. Two complaints were reviewed – one complaint was of tree branches overhanging the roadway on Fir Street and the other were bushes and branches overhanging the sidewalk along multiple properties on 5th Street. Property owners were notified. The property owner at the corner of Juniper Lane has cut theirs back already.
